*Absys Cyborg, leader in the integration of the product offering of the publisher Sage, reinforces its presence in the Western region by completing the acquisition of the company **SBI**, a Breton specialist in the integration of the Sage ERP X3 and Sage PME (small- and medium-sized businesses) solutions.*

**Levallois-Perret, 10 January 2012 : Absys Cyborg**, a subsidiary of the **Keyrus** group and a major player in the implementation of, and the provision of support for, management solutions intended for small- and medium-sized businesses/industries and group subsidiaries, announces that it has acquired the company **SBI**, a long-standing integrator of **Sage** products.

**Absys Cyborg** thereby reinforces its presence on the French market and aims to become **Sage's** main partner for the Sage ERP X3 product offering, which represents a comprehensive solution supplying as standard a functional richness which is essential to the effective management of the business (Finance, CRM, Sales, Purchases, Stocks and Production).

This tie-in allows the company to move on to a new stage in its development project centred around this line of products and to capitalise on areas of business-line expertise which have historically been developed by SBI : Electronics, Trade, Import – Export,...

Set up over 20 years ago in the Finistère area, **SBI** is a regional company with 12 members of staff which has made its mark in partnership with leaders in the software and hardware-manufacturing market (HP, IBM, Adonix and Sage).

Focused today on **Sage's** product offerings, the **SBI** team is made up of senior consultants with a wealth of experience derived from their numerous successful projects in various sectors of activity. It is a profitable company whose 2011 turnover stood at 1.3 M€, up by 7% in relation to the previous financial year. It today has 180 loyal clients who value a localised, quality-driven approach.

With 365 members of staff and 3,800 clients, and faithful to its development strategy centred around its two long-standing publisher partners, **Sage** and **Microsoft Dynamics**, **Absys Cyborg** achieved a turnover, during the first 9 months of 2011, of 28.4 M€, up by 10% in relation to the previous financial year, confirming its ability to grow rapidly and in a profitable manner.
